In view of above, the application for renewal of Fire Safety Certificate is not considered at this stage & rejected. The occupancy of the building/ premises in absence of requisites fire safety measures shall be at the risk and liabilities of the owner/ occupier.


Sir,

This has reference to ID No. 2025101314151 dated 13.10.2025, on the subject cited above, it is to inform you that the site was inspected by the officer concerned of this department on 25/10/2025 in the presence of Sh. Sai Ram (Manager) and the following shortcomings were observed:-

1. Main staircase found reduced to 1.5 m against the requirement of 2 m.
2. Smoke management system found removed in basement.
3. Exit Signage found removed.
4. Underground water tank found empty.
5. Pump not in auto mode provision.

In view of above, the case is rejected and Fire Safety Certificate (FSC) cannot be renewed at this stage. Therefore, you are requested to rectify the above shortcomings and re-submit for further consideration in the matter.
