- 4. Terrace pump of 225 LPM is provided against the requirements of 450 LPM.
- 5. No. of rooms being used using in the guest house as per building plans are not matching with the guest room filled in online application. Further, no. of room at fourth floor are not

allowed (as mentioned in online application) as per gazette notification dated 27.05.2019. allowed (as menuoned in online application, and fill the correct in formation in Therefore, you are requested to rectify the above shortcomings and fill the correct in formation in
