In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.

Madam/Sir,

Please refer to your letter no. HLJ/B/2019/6518 dated 20.09.2019 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school on 25.11.2019 to verify the fire safety arrangements in accordance with the circular No. F.16/Estate/CC/Fire Safety/2011/3298 to 3398 dated 01.03.11 issued by the Director of Education. At the time of inspection Principal of the school was present and it was observed that the school building is comprised of ground plus three upper floors and have following shortcomings:-

1. First Aid Hose reels not provided at each floor.
2. Fire pump having capacity 450 LPM out put with 40 m head not provided.
3. Over head water storage tank of 10,000 liters capacity is required exclusively for firefighting.
4. Exit signs are not found provided.

In view of above, the fire safety certificate cannot be issued. You are suggested to rectify the above said shortcoming under the intimation to this department for further course of action.
