This has reference with MCD Portal ID 2025031903985 dated 31/03/2025 on the subject cited above. In this connection, this is to inform you that the above. mentioned premise was visited by the officer concerned of this department on 09.04.2025 in the presence of Mr. Sanjay Kumar (Manager) to verify the fire safety measures installed in the building. Accordingly fire safety arrangement were tested / checked and found following observation.

- 1. Smoke ventilation system not provided in the building as per clause 7.31 of UBBL 2016.
- 2. Carbon Monoxide detector not provided as per clause 7.31 of UBBL 2016.

MOEFA not working.

4. The occupancy above 3rd floor is not allowed as per clause 7.31 of UBBL 2016.

5. Exit Signage found removed at some places.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
