This has reference with MHA Portal ID 2023100716944 dated 07-10-2023 on the subject cited above. In this connection, the premises have been inspected by officer concerned of this department on 18.10.2023 in the presence of Mr. Laxman of the Guest House. During the inspection, it was observed that the Guest House is running Basement, Ground plus Three Upper Floors. The shortcomings observed are as below:

1. The Occupancy above 3rd floor not acceptable as per clause 7.31 in UBBL 2016.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
