Kindly reference to online e-mail dated 16.12.2024, received in this department on the subject cited above. The premise was inspected by the concern nominated authority of this department on **02.04.2025**, in presence of **Mr. Pankaj Gupta** to ascertain the availability and operability of the fire prevention and fire safety measures. Your request for renewal of FSC is rejected under sub rule (3) of Rule 37 of DFS Rules-2010 due to following reason:

- 1. 6 meter road all around the building at corner side reduced due to construction of temple.
- 2. Auto starting/Manual stopping system of pumps not functional.

In this regard as stipulated in sub Rule 37 of DFS Rules, 2010 you may apply with a fresh application for renewal of fire safety certificate under sub-rule (2) on Form "J" with compliance of above shortcomings.
