Inn Guest House located at 4400, Katra Raiji, Basant Road, Pahar Ganj, New Delhi, comprised of Ground + 03 upper floors: Ground floor -Reception + 02 guest rooms - 1st floor - 02 guest rooms, 2nd floor- 03 guest rooms, 3rd floor-03 guest rooms, total 10 guest rooms was granted Fire Safety Certificate (FSC) by this department vide letter no. F6/DFS/MS/GH/NDZ/2019/940 dated 06.05.2019. The premises was re-inspected by officer concerned of this department on 28.01.2025 in presence of Mr. Muttafique Raza (Manager) and found that building/premises comprised of Ground + 04 upper floors: Ground floor - Reception + 02 guest rooms - 1st floor - 02 guest rooms, 2nd floor- 03 guest rooms, 3rd floor - 03 guest rooms, 4th floor - 02 rooms (not in use). The building has complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of Group 'A (Residential) sub division A-1, total 10 guest rooms (Ground floor - Reception + 02 guest rooms - 1st floor - 03 guest rooms, 2nd floor- 03 guest rooms, 3rd floor- 03 guest rooms) and valid upto 31.03.2028 in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.

Conditions for the validity of Fire Safety Certificate

- All the fire safety arrangements provided therein shall be maintained in good working condition at all times.
- 2. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
- 3. The trained fire fighting staff should be available round the clock.
- 4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
- 7. The means of escape shall be kept unobstructed/unlocked for unhindered evacuation in case of an emergency.
- 8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.

The shortcomings issued to the building vide letter no. F6/DFS/MS/GH/NDZ/2024/749 dated 31.12.2024 has been rectified by the management.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/NDZ/2019/940 dated 06.05.2019 is recommended to be renewed under Rule 37 of the Delhi Fire Service Rules 2010
