ORDER

Whereas, The Dashmesh Cooperative (U) T&C Society Ltd., having registration no. 702-TC is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 and rules framed thereunder.

Whereas, elections of the Managing Committee of The Dashmesh Co-operative Urban Thrift & Credit Society Ltd. conducted during January, 2024 to February, 2024 were set aside by the Ld. Arbitrator vide order dated 05.11.2025 passed in Case No. 5622/AR/ARB/2023-24.

And whereas, the appeals preferred by the said Society against the aforesaid Arbitrator order before the Hon'ble Delhi Co-operative Tribunal were dismissed vide judgment/order dated 19.03.2026 passed in Appeal No. 002/2026/DCT and Appeal No. 003/2026/DCT.

And whereas, complaints/representations have been received alleging that despite the setting aside of the elections, the existing Managing Committee is continuing to manage the affairs of the Society.

And whereas, upon consideration of the facts and circumstances of the case and in the interest of proper administration of the Society and conduct of fresh elections, it has been considered necessary to appoint an Administrator-cum-Returning Officer.

Now, therefore, I, Anil Kumar, Deputy Registrar (T&C) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri Sumit, Section Officer, O/o the RCS Delhi as Administrator-cum-Returning Officer in The Dashmesh Cooperative (U) T&C Society Ltd., under Section 35(5) r/w Section 35(1) of DCS Act, 2003.

A sum of Rs. 10,000/- (Rupees Ten thousand only) per month as remuneration plus conveyance allowance will be paid to him from the Society's fund. The Administrator-cum-Returning Officer may hold election within a period of 90 days.

The expenses for conducting the election shall be met out from the fund of the Society. The election of MC of the Society shall be conducted as per the provisions of the Act & Rules of DCS Act.

This issues with the prior approval of the Competent Authority.
