CIRCULAR/T&C FOR 2025-2026

Subject: Renewal of License in form of L-11 for period w.e.f. 01.07.2025 to 31.03.2026

1. It has been decided by the Competent Authority to renew all existing L-11 Licensees for the period w.e.f. 01.07.2025 to 31.03.2026 on payment of proportionate license fee and additional fee **as per timelines prescribed in the point no. 4 of circular** for the said period subject to the following conditions:

- a. All the licenses of L-11, are hereby directed to submit their application for renewal of license online by accessing their account in EABKARI portal (applicant) through their Ex. I.D. and password along with the applicable license renewal for the period w.e.f. 01.07.2025 to 31.03.2026 by providing requisite information and payment of renewal license fee **as per timelines prescribed in the point no. 4 of circular**.
- b. The Licensee should ensure that the licensed premises remains in their legal possession during the currency of license as required under section 13 (1) (f) of the Delhi Excise Act, 2009. Accordingly, the license fee will be levied as per structure given below:

ANNUAL FEE STRUCTURE FOR L-11 (Rounded off to nearest Rupee)

capacity (per day)	License fee for Excise year 2024-25	Applicable License fee for the period of 12 months w.e.f. 01.04.2025 to 31.03.2026
upto 500 Ltr	250000	250000
upto 1000 Ltr	500000	500000

2. The Department reserves the right to review the license fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit or take any other suitable action.



3. All applications for renewal with license fee must be submitted **as per timelines prescribed in the point no. 4 of circular** The licensee should submit renewal application with fee by due date accessing their account in EABKARI portal (applicant login) through their Ex. I.D. and password along with the acceptance of Declaration.

4. Timelines for payment of licensee fee for renewable licenses-

S.No.	Timelines	Fee to be paid
1	Within 30 days of issuance of circular for renewal	Only requisite License fee (pro-rata) as per category of the license shall be paid.
2	30 days to 60 days of issuance of circular for renewal	Additional fee of 25% of Annual license fee (pro-rata) along with License fee (pro-rata) as per category of the license shall be paid
3	Beyond 60 days of issuance of circular for renewal	Additional Fee of 100% of Annual license fee (pro-rata) along with License fee (pro-rata) as per category of the license shall be paid

Note:- Respective L-16, L-17, L-18 or L-19 license have to be renewed prior to applying for renewal of L-11 License.

This issues with the prior approval of the Competent Authority.
