CIRCULAR

Subject: Renewal of License in form of L-15/L-15F and L16/L16F for period w.e.f. 01.04.2025 to 30.06.2025.

1. It has been decided by the Competent Authority to renew all existing L15/L-15F and L-16/L-16F, for the period w.e.f. 01.04.2025 to 30.06.2025 on payment of proportionate applicable license fee and additional fee **On OR BEFORE 31.03.2025** for the said period subject to the following terms & conditions:

A. All the licenses of L15/L-15F and L-16/L-16F, are hereby directed to submit their application for renewal of license online by accessing their account in EABKARI portal (applicant login) through their Ex. I.D. and password along with the applicable license renewal fee for the period w.e.f. 01.04.2025 to 30.06.2025 by providing requisite information and payment of renewal license fee **on or before 31.03.2025**.

B. The Licensee should ensure that the licensed premises remains in his legal possession during the currency of license as required under section 13 (1) (f) of the Delhi Excise Act, 2009.

C. As per the Notification No. F.12(4)/Fin(Rev-I)/15-16/dsvi/587 dated 22.07.2015 issued by Finance Department, GNCT of Delhi to increase license fees at the rate of 10 % per annum and accordingly the revised annual license fee and additional fee, as applicable, will be levied on proportionate basis for the period of 03 months on the revised fee structure as given below:

- D. The Motel already classified by, Govt. of India, Ministry of Tourism, shall pay license fee on the basis of that classification until their reclassification.
- E. **24x7 SCHEME:**
 "Fee for service of liquor round the clock for 4 Star hotels, 5 Star hotels, 5 Star Deluxe and above category hotels and Motels (Deluxe) shall be additional 50% of the basic annual licence fee of that particular restaurant"
- F. All the Five Star & above Category hotels who have already taken permission for opening one or more L-16/L-16F unit, round the clock (24X7) have to apply for the permission afresh for the next Licensing Year. The scheme is open to all the Hotels classified under Four Star, Five Star and Five Star Deluxe and above Category.

- G. The Department reserves the right to review the license fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit or take any other suitable action.
- H. All Licensees are required to submit mandatory linked licenses along with other documents in document revalidation link available at EABKARI portal failing which License renewal will be stopped.
- I. All applications for renewal with license fee must be submitted online ON OR BEFORE 31.03.2025 through License Renewal Link in EBKARI Portal. Licensee can access EABKARI portal (applicant) through their Ex. I.D. and password.
