CIRCULAR

Subject: Renewal of License in form of L-17/L-17F, L-18/L-18F, L-19/L-19F and L-20/L-20F for period w.e.f. 01.04.2025 to 30.06.2025.

1. It has been decided by the Competent Authority to renew all existing L-17/L-17F, L-18/L-18F, L-19/L-19F and L-20/L-20F for period w.e.f. 01.04.2025 to 30.06.2025 on payment of proportionate applicable license fee and additional fee **On OR BEFORE 31.03.2025** for the said period subject to the following term & conditions:

A. All the licenses of L-17/L-17F, L-18/L-18F, L-19/L-19F and L-20/L-20F, are hereby directed to submit their application for renewal of license online by accessing their account in EABKARI portal (applicant login) through their Ex. I.D. and password along with the applicable license renewal fee for the period w.e.f. 01.04.2025 to 30.06.2025 by providing requisite information and payment of renewal license fee **on or before 31.03.2025**.

B. The Licensee should ensure that the licensed premises remains in his legal possession during the currency of license as required under section 13 (1) (f) of the Delhi Excise Act, 2009.

C. As per the Notification No. F.12(4)/Fin(Rev-1)/15-16/dsvi/587 dated 22.07.2015 issued by Finance Department, GNCT of Delhi to increase license fees at the rate of 10 % per annum and accordingly the revised annual license fee and additional fee, as applicable, will be levied on proportionate basis for the period of 03 months on the revised fee structure as given below:

- E. All Licensees are required to submit mandatory linked licenses along with other documents in document revalidation link available at EABKARI portal failing which License renewal will be stopped.
- F. All applications for renewal with license fee must be submitted online **ON OR BEFORE 31st March 2025** through License Renewal Link in EBKARI Portal. Licensee can access EABKARI portal (applicant login) through their Ex. I.D. and password.


