Please refer your online File No. ADG DELHIREGION20230525/2341 dated 29.05.2023 on the subject cited above. In this connection this is to inform you that the referred building plans have been scrutinized by this department from life/fire safety point of view and observed following shortcomings:

- 1. 6.0 meter wide fire tender movement road along with 9.0 meter turning radius is not proposed on the plan as per clause 8.2 (b) of UBBL 2016.
- 2. Width of main gate is not as per the clause 8.2 of UBBL 2016.
- Arrangement of exit is not as per clause 7.5.10 of UBBL 2016 on upper ground floor.
- Fire Control Room is not proposed as per clause 9.3.10 of UBBL 2016.
- 5. Level at terrace plan is not matching with section plan.
- 6. Capacity of overhead fire tank is not proposed as per NBC- Part-4.
- 7. Smoke management system is not proposed.

Therefore, plans are rejected with request to re-submit plans after rectification of above shortcomings.
