- 1. Detector found non functional at some offices.
- Electrical shaft are not sealed at floor level.
- 3. PA system found non functional.
- 4. Pressurization of lift lobby & shaft found non functional.

In view of above shortcomings, the application for issuance of FSC is rejected. The occupancy in the building without requite fire safety arrangement shall be at risk and liability of owner /occupier of the building. The statuary /licensing authority may take necessary action as deemed fit.
