In view of above, Fire Safety Certificate (FSC) cannot be issued at this stage. Therefore, you are requested to submit the point wise compliance of aforesaid letter for further consideration in the matter.

Sub: - Regarding regularization/ approval from fire safety point of view of Mata Sundri College for women building at Mata Sundri Road, New Delhi.

Sir,

Please refer to your letter no. MSC/ADMN/3251/2017-2558 dated 24.11.2017 received in this office on 12.12.2017 on the subject cited above. In this connection, this is to inform you that the plans submitted in respect of proposed / existing blocks at Mata Sundri College, Mata Sundri Road, New Delhi have been scrutinized from fire safety point of view and observed that two blocks namely Administrative Block comprised of ground mezzanine plus four upper floors and Auditorium Block comprised of ground, mezzanine plus two upper floors have been proposed for approval. The height of the proposed blocks is Administrative Block – 19.5 meter and Auditorium Block not mentioned. Following shortcomings have been observed in the plans:

Administrative block

 The plans have not been forwarded through building sanctioning authority i.e North Delhi Municipal Corporation.

2. Fire safety arrangements as per UBBL-2016 / NBC Part-IV 2016 have not been marked on the

plans.

3. Six meter road wide road for fire tender movement has not been proposed in the plans.

4. Width of staircases and doors has not been mentioned in the plans.

5. Terrace plan has not been submitted with the plans.

6. Fire control room has not been proposed on the plans.

7. Terrace tank for fire fighting, pump & inspection ladder has not been marked on the plans.

Auditorium Block

 The plans have not been forwarded through building sanctioning authority i.e North Delhi Municipal Corporation.

2. Sitting plan has not been submitted with the plans.

3. Fire safety arrangements as per UBBL-2016 / NBC Part-IV 2016 have not been marked on the plans.

4. Width of doors has not been mentioned in the plans.

5. Terrace plan has not been submitted with the plans.

6. Elevation and section plan has not been submitted with the plans.

7. Terrace tank for fire fighting, pump & inspection ladder has not been marked on the plans.

In view of the above, the applicant may be requested to submit the plans after rectifying the above said shortcomings for further necessary action.
