Please refer to your letter no. nil dated 29/08/2013 on the subject cited above. In this connection this is to inform you that the inspection of the above said premises was carried out by the officer concerned of this department along with school authority on 27/09/2013 from fire safety point of view and following shortcomings were observed.

The four classrooms where no. of students is more than 45 students require two door 1. of one meter width each. Provide one additional exit of one mtr width in four classrooms.

2. ` First hose reel required to be provided at each floor.

One fire pump of 450 LPM with 40 m head is required to be provided at terrace. 3.

Over head water storage tank of 10,000 ltr capacity is required to be provided. 4.

Keeping in view of the above fire safety certificate cannot be considered at this stage. You are requested to provide the fire safety arrangements as per the circular of Director of Education issued vide letter No F-16/estate/cc/fire safety/2011/3298-3398 dated 01/03/2011.
