Sub: - Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o M.C. Primary Modal school-1 (Girls), Gali Quasim Jaan, Delhi-110006 Madam,

Please refer to your letter No. Nil dated 16.12.2013 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school on 17.1.14 to verify the fire safety arrangements in accordance with the circular No. F.16/Estate/CC/Fire Safety/2011/3298 to 3398 dated 01.03.11 issued by the Director of Education. At the time of inspection Principal was present.

It was observed that the school building comprises of ground floor only. Fire fighting systems such as fire extinguishers and fire buckets were found provided and following shortcoming was observed :-

1. The school building is not accessible to fire engine as the width of the approach road is less than six meters.

In view of above, the fire safety certificate cannot be issued at this stage.
