Sir,

This is in reference to your letter No. EE(Elect.)-II/SHN(S)/2023-24/D-18 dated 17/04/2023 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned School from fire safety point of view on dated 25/05/2023 in presence of Mrs. Menu Puri, In-charge of the School. The building comprised of ground plus two upper floors. Following shortcomings were observed during the time of inspection.

- 1. One staircase of width 1.30 meter is provided against requirement of two staircase of width 1.50
 - 2. Overhead water storage tank capacity 5000 liters is provided against requirement of 10,000 liters.
 - 3. Exits signage not provided.

In view of the above, the building cannot be considered for issuance of Fire Safety Certificate at this stage. Therefore, you are requested to provide the above mentioned fire safety arrangements under intimation to this office for further course of action.
