This has a reference to complaint no. Nil dated 13/09/19 copy enclosed, received in this office from the office of Dy. Chief Minister. In this connection this is to inform you that officer concerned of this department inspected the school to verify the fire safety arrangements in accordance with the NBC Part-IV. At the time of inspection Manager was present and it was observed that the school building is comprised of ground plus three upper floors and school is running at all three floors in stead of ground plus one upper floor when FSC was issued earlier in the year 2015.

Following shortcomings are observed:-

- 1. Width of second staircase is less than 1.50 meter.
- 2. Overhead tank 10000 liter is not provided.
- 3. Exit signage's are not provided.

In view of above, You are requested to rectify the above shortcoming under the intimation to this department for further as deem necessary in the matter.
