F6/DFS/MS/School/NDZ/2025/229 dated 17.04.2025 (Photocopy overleaf) has not been rectified till date.

In view of above shortcomings, the application for issuance of Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the school management. The Statutory Authority may take suitable necessary action as deemed fit.

Sir,

This has a reference to your Outdoor Diary No. 14604 dated 18/03/2025, on the subject cited above. In this connection, it is to inform you that premises was inspected by the officer concerned of this department on 07/04/2025 in the presence of Mr. Satish Kumar Bhati (Principal) and observed that building comprised of ground plus two upper floors.

**Following shortcomings were observed during time of inspection:**

1. First-Aid-Hose Reel not provided.
2. Terrace level fire pump capacity of 450 LPM not provided.
3. Overhead tank of capacity 10,000 liters not provided.
4. Exit & floors Signage's not provided at strategic location in the building.

In view of above shortcomings, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the management. The Authority/Statutory Authority may take suitable necessary action as deemed fit.
