Now the building/premises was re-inspected by the officer concerned of this department on 05/01/2026 in the presence of Mr. Shivam Gupta, Owner and found that the said building is comprised of Ground & 04 upper floor and now the floor wise occupancy is ground floor (commercial use), 1st floor - (reception +11 guest room), 2nd floor - (15 guest room), 3rd floor - (15 guest room) & 4th floor - not in use as per affidavit dated 08.01.2026. The building has deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class - (Residential Group A-1) total 41 guest rooms upto third floor only, with effect from **21/01/26** for period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010, printed below.

Conditions for the validity of Fire Safety Certificate

1. This FSC is valid for guest house upto third floor only. The occupancy of 4th floor not allowed as per clause 7.31 in UBBL-2016
2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
3. Any loss of life or property due to nonfunctional fire safety measures shall be at the responsibility of the management.
4. The trained firefighting staff should be available round the clock.
5. Any deviation w.r.t. construction, electric installation, set back area etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
8. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
9. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six months prior to its expiry.
10. Any flammable material for interior decoration is prohibited.

The owner has submitted an affidavit dated 08.01.2026 stating not to use any floor above third floor for any purpose.


