This has reference to your mail id <directorlhmc@gmail.com> dated 27.05.2024, on the subject cited above, it is to inform that the site was inspected by the officers concerned of this department on 13/06/24 in the presence of Sh. Ranjeet (JE) and the following shortcomings were observed.

1. Detector found non functional at some offices.
2. Electrical shaft are not sealed at floor level.
3. PA system found non functional.
4. Pressurization of lift lobby & shaft found non functional.

In view of above shortcomings, the application for issuance of FSC is rejected. The occupancy in the building without requisite fire safety arrangement shall be at risk and liability of owner /occupier of the building. The statutory /licensing authority may take necessary action as deemed fit.
