

Subject:- Extension of "Mission Sahibi River (MSR), DJB" ---- A Dedicated Cell to Restore and Protect the Sahibi River.

In continuation to Office Order No.64 dated 17.04.2025, it is hereby ordered that under Mission Sahibi River (MSR), DJB shall now undertake comprehensive field visits to identify sourced of untreated sewage entering the drains for the remaining stretch of approximately **46 Kilometers** of the Sahibi River within the NCT of Delhi, beyond Punjabi Bagh. This exercise shall also cover the **Supplementary Drain** of approximately 35 Kilometers and **Jhangir Puri Drain** of approximately 06 Kilometers, to be conducted in a phased manner within the minimum possible timeline.

This extension is being initiated post the successful survey and recommendations under phase-I, covering the 11- Kilometer stretch from Timarpur to Punjabi Bagh.

Reporting and Monitoring:

- A review meeting will be convened by the CEO, in presence of **Member(Dr.)** and concerned **Chief Engineers(Maintenance)** to assess progress and resolve key issues.
- The **Mission Director(MSR)** shall be responsible for submitting reports to the CEO and **Member(Dr.)**.
- A **preliminary report** on the current extension shall be submitted **within 15 days** from the issuance of this order.

Financial Provisions:

- An amount of **Rs.1.00 Lakh** (Rupees One Lakh only) may be utilized from the Revenue Head under '**Meeting and Seminar**' or under any other appropriate head to be created/decided by the Concerned Wing, for the following purpose:
- Creation of audio-visual content (video/documentation) for public outreach,

This order comes into force with immediate effect.


