
**ORDER**

Of personnel & Training) the Principal Director, DFS is pleased to grant 1<sup>st</sup>/ 2<sup>nd</sup> / 3<sup>rd</sup> Financial up gradation to below mentioned Officer/Officials i.e. Leading Fireman, Fire Operator and MTS on completion of 10/20/30 years of regular service, from there corresponding Grade Pay to the immediate next higher Grade Pay. The Head of office concerned is requested to ensure, before granting the Financial up gradation under the Modified Assured Career Progression Scheme to Officer/Officials i.e. Leading Fireman, Fire Operator and MTS that 10 years regular service does not include the period of service rendered in State Government /Statuary Body/ Autonomous
