1. The internal road of 6 mtr wide found encroached at one side by installing DG Sets, Transformer and electrical room, which needs to be clear for fire tender movement all around the building. It to you would have also add to be attenue, narro

Staff cafeteria found running at terrace level by erecting temporary Air 2.

Conditioning structure, which needs to be removed.
