The site was visited by a team of officers from this department on 15.04.2025 for JSI in alongwith M.J. Rana, J.E.(Bldg.) and following observations were made:

- 1. The JSI has been received for commercial occupancy which does not clarify the actual occupancy of the building as per clause 1.4.75 of UBBL 2016.
- 2. The actual on site occupancies as observed/noticed at the time of inspection was as follows:
 - Basement Vacant. a.
 - Stilt Parking. b.
 - Ground Bank ATM + Vacant office space + Shop.
 - 1st & 2nd floor Coaching Centres.
 - 3rd & Terrace Kibou Restaurant. e.

The restaurant at 3rd floor has already been issued FSC vide letter F6/DFS/MS/2024/EH/325 dated 11.10.2024. The Coaching centres at 1st and 2nd floor have already applied for fire safety clearances through MCD portal ID no. 70000083 & 70000055 as per records available with this department.

Both the above occupancies i.e. Assembly & Educational are covered under Rule 27 of DFS Rules 2010 and have already been considered by this department as separate cases received from different portals and the building may be considered a mixed occupancy. However, the applicant has applied for clearance of commercial occupancy which needs to be rectified in the CAF.

Hence, the case received for OCC is rejected.

Conditions for the validity of Fire Safety Certificate:

1. This Fire Safety Certificate is valid only for restaurant at third floor. In case of any violation, this FSC will be treated as null & void.

2. All the means of escape shall be kept free from any type of obstruction all the time.

3. All the employees shall be acquainted with the use and maintenance of all fire equipment and method of smooth and speedy safe evacuation of occupants in case of emergency

4. All the fire safety arrangements provided therein shall be maintained in good working condition at all time as seem during inspection. Any loss of life or property due to nonfunctional fire safety measures shall be at the responsibility of the management.

5. Any deviation, with regards to construction, ventilation, occupancy, electric installation etc. may be got verified from the concerned authorities. This Fire Safety Certificate is valid only for permanent building structure as per plan.

6. This fire safety certificate may not be treated in any case of regularizations of unauthorized construction/unauthorized use of land or activities, if any.

7. Basement shall not be used for any other purpose except as specified in UBBL, subject to
