

Kashinath (Site Manager) to verify the compliance of shortcoming communication vide letter No F.6/DFS/MS/Resdl/2025/SZ/149 dated 07/04/2025 and observed that shortcomings are still not fully complied.

In view of the above, application for renewal of fire safety certificate is rejected. The occupancy of the building/premises in the absence of requisite fire safety measures/valid Fire Safety Certificate shall be at the risk and liability of the owner/occupier/management.

Please refer to your letter No. GDK/OIDPL/OM/198 dated 27/01/2025, on the subject cited above. In this regard, the above-mentioned residential complex has been inspected by the officer concerned of this department on 25/03/2025 in presence of Sh. Kashinath (Site Manager) from fire & life safety point of view. During course of inspection, the shortcomings observed are as below: -

1. Six-meter-wide internal road around the building found blocked.
2. Automatic sprinkler system in basement needs to be extended in left out areas.
3. Exit & lift signage's found removed at some locations.

In view of the above, application for renewal of fire safety certificate is rejected. The occupancy of the building/premises in the absence of requisite fire safety measures/valid Fire Safety Certificate shall be at the risk and liability of the owner/occupier/management.
