FIRE SAFETY CERTIFICATE

Certified that the Raj Lata Public School at Plot No. 1, Gali No. 2, Nasirpur, Near Kailash Puri, Palam Colony, New Delhi–110045, comprised of ground plus one upper floor & one room at terrace for chowkidar, owned/occupied by Raj Lata Public School, was issued Fire Safety Certificate by this department vide letter No. F.6/DFS/MS/School/2022/SZ/1089 dated 29/09/2022. The premise was re-inspected by the officer concerned of this department on 10/11/2025 in the presence of Sh. Sandeep Joshi (Manager) and observed addition of rooms at second floor in the building but not in use/occupied. Therefore, the school building up to first floor only have deemed complied with the fire prevention and fire safety requirements in accordance with the Directorate of Education Circular No. F.16/Estate/CC/Fire Safety/2011/3298 to 3398 dated 01.03.2011 issued by Director of Education, Govt. of NCT of Delhi and that the school premise/building is fit for occupancy class "Educational Group B" with effect from 26/11/2025 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

Conditions for the validity of Fire Safety Certificate: -

- This FSC is valid for school building up to 1st Floor only. The school management shall not use/occupy 2nd Floor of the building for school activity as per undertaking dated 17/11/2025, failing which this FSC shall stand null and void
- 2. All the means of escape/entry/exit shall be kept free from any obstruction.
- 3. All the fire safety arrangement provided therein shall be maintained in good working conditions at all time as seen during inspection. Any loss of life property due to non-functional fire safety measures shall be at the responsibility of the management.
- 4. All the staff members must know the correct method of operation of fire-fighting system.
- 5. This fire safety certificate may not in any way be treated as regularization (Clause 2.8 of UBBL-2016) of unauthorized construction or alteration (Clause 1.4.3 of UBBL-2016), if any.
- 6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule37] along with a copy of this certificate, prior to its expiry.
- 7. The owner/occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in

In view of the deemed compliance of the minimum standards on fire prevention and fire safety as required under DOE Circular dated 01/03/2011, the fire safety certificate issued vide letter No. F.6/DFS/MS/School/2022/SZ/1089 dated 29/09/2022, renewal under rule 37 of the Delhi Fire Service Rules, 2010 is recommended.
