In this context it is informed that the said Banquet Hall was inspected by officer concerned of this department on 22.05.2025 in the presence of Mr. Nadeem Malik (Manager) and it was observed that the shortcomings issued to the Banquet Hall vide letter no. F.6/DFS/MS/BNQT/2025/SZ/73 dated 01.05.2025 (Photocopy overleaf) has not been rectified completely till date. Hence FSC to the building cannot be considered at this stage.

In view of above shortcomings, the application for issuance of Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the management. The Statutory Authority may take suitable necessary action as deemed fit.

In this connection, this is to inform you that the above mentioned premise was visited by the officers concerned of this department on 12.04.2025 in the presence of Mr. Vinay Aggarwal to verify the fire safety measures installed in the building. Accordingly fire safety arrangement were tested / checked and found following observation.

1. The Rear side exit gate found blocked.
2. Automatic detection system found removed at some area in banquet hall.
3. MOEFA found removed at some locations of banquet hall.
4. Automatic sprinkler System found removed at some area in banquet hall.
5. Exit signage's found removed.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
