During inspection, it has been observed that the shortcomings issued by this department vide above said letter has not been rectified yet.

In view of the above, the application for issuance of Fire Safety Certificate cannot be considered at this stage & rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing Authority/statutory Authority may take suitable necessary action as deemed fit.

This has a reference to your MHA Application no. 202405106582 dated 08/05/2024, on the subject cited above. In this connection, it is to inform you that premises was inspected by the officers concerned of this department on 30.05.2024 in the presence of Mr. Kuldeep Bhadauria (Owner) and observed that building comprised of two basement + ground + 03 upper floors only. (Banquet Hall is Ground floor only).

Following shortcomings were observed during time of inspection:

- Two Exit doors of width 2.0 meters and 1.05 meters are provided instead of required width of 2.0
 4.50 meters.
- 2. Fire check door not provided.

In view of above shortcomings, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the management. The Authority/Statutory Authority may take suitable necessary action as deemed fit.
