Sir,

This is in reference to your letter no. Nil dated 25.2.2019 on the subject cited above. In this connection, it is to inform you that above said school building have been inspected by the officer concerned of this department on 07.05.2019 in presence of Smt. Kusum Lata (Head of School) to check fire safety arrangements provided in the building as per Circular issued by the Directorate of Education GNCT of Delhi dated 1.3.2011.

During the course of inspection it has been observed that the premise consists of ground and first floor. The following points have been noticed as shortcomings:-

1. The School building is not accessible for fire tenders as width of access road is 2.80 Meters instead of required width 6 Meters.

In view of the above shortcoming fire safety certificate cannot be granted.
