- This has reference to your e mail narenderkr.singhal@gmail.com Dated 09.03.21 on the subject cited above. In this regard, it is to inform you that the site (Block A & B (Annexe_I&II) was inspected by the officers concerned of this department on 24/03/2021 in the presence of Sh. Narendra Kumar (SSE) and the following shortcomings were observed:-
 - 1. Alternate staircase at block -B (Annexe -II) found blocked/locked.
 - 2. Fire check doors found broken at some places.

3. Corridors found encroached at some places.

- 4. Compartmentation is required in basement by erecting a wall to restrict of the smoke to upper floors.
- 5. Electrical shafts are not sealed horizontally /vertically.
- 6. Hose reel found nonfunctional.
- 7. Detectors found nonfunctional.
- 8. Sprinklers are required to be extended in left out areas of corridors.
- 9. MOEFA found nonfunctional.
- 10. PA system found nonfunctional.
- 11. Overhead water tank of 20000 ltr. is not provided at block -A (Annexe-1).
- 12. Pressurization in lift shaft not provided.
- 13. Exit/lift signages are not provided.

In view of above shortcomings, the application for issuance of Fire safety certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The licensing /statutory authority may take suitable necessary action as deemed fit
