Subject: - Renewal of Fire Safety Certificate in r/o Sanmati CGHS Ltd., Plot No.19A, Sector-6, Dwarka, New Delhi.

Sir,

Please refer to your letter no. NIL dated 14.10.2019 on the subject cited above. In this connection it is to inform you that the said residential building was inspected by the officer concerned of this department on 21.11.2019 in presence of Sh. OP Joshi (President) and Sh. Diwakar Sharma (Secretary) to check the workability of fire fighting systems provided therein.

During inspection followings shortcomings have been observed:-

1. Width of internal road all around the building is 5.80 Mtrs. instead of required width of 6 Mtrs.
2. Width of staircase is 1.10 Mtrs. in each block instead of required width of 1.25 Mtrs..
3. MOEFA is provided but not functional.
4. Public address system is provided but not found functional.
5. Fire pumps not found on auto-operation.
6. Exit signage found removed at some locations.

In view of the above shortcomings Fire safety certificate cannot be renewed. You are advised to rectify the above said shortcomings under intimation to this department for taking further necessary action.
