Accordingly fire safety arrangement were tested / checked and found following observation.

1. There is addition of First Floor in 4th block, only one staircase is provided having width of 1.50 mtr against the requirement of two staircase having width of 1.50 mtr each.
2. Service staircase to access of terrace tank is needed to be provided for verification of terrace tank & terrace pumps.
3. Hose reel hose not working.
4. Fire fighting pumps are not working.
5. Exit signage found removed at some places.

The same observations has already been issued and communicated earlier by this department vide letter of even no 372 dated 13/05/2025 & letter of even no 150 dated 12/03/2025.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.
