The premises was re-inspected by the officer concerned of this department on 09/07/2025 in the presence of Sh. Satish Kumar (Vice-Chairman) and observed that all the fire prevention and fire safety arrangements provided in the premises found in good working condition. The premises have therefore deemed complied with rule 33 of the Delhi Fire Service Rules, 2010 and found that the school building is fit for Ground plus two upper floors occupancy class "Educational" (Group-B) with effect from 25/ 07/2025 for a period of three years in accordance with rule 36 unless renewal under rule 37 or sooner cancelled under rule 40 and subject to compliance of the conditions under rule 38 of the DFS rules, 2010.
