INSTRUCTIONAL ORDER

Subject: Provision of Adequate Water Supply in Kanwar Yatra 2025 Camp Areas – Coordination with DMs and Irrigation & Flood Control Department.

The annual Kanwar Yatra is scheduled to commence on **July 11, 2025**. As in previous years, a significant number of devotees are expected to pass through and set up temporary camps within the National Capital Territory of Delhi. To ensure the well-being and convenience of these pilgrims, it is imperative that adequate water supply is provided in and around the camp areas, especially considering the ongoing monsoon season.

In light of the above, the following instructions are hereby issued for strict compliance and immediate action by all concerned Delhi Jal Board (DJB) officials, with a strong emphasis on inter-departmental coordination with the District Magistrates and Irrigation & Flood Control (I&FC) Department:

1. Water Supply Arrangements:

- **Identification of Camp Locations:** All Superintending Engineers (SEs) of concerned zones, particularly those in East Delhi, North East Delhi, Shahdara districts (identified as primary entry points and high-density camp areas) and on other locations falling under the jurisdiction of GNCT, Delhi shall immediately coordinate with the District Magistrates (DMs) and Delhi Police for quick response.
- **Assured Potable Water Supply:**
 - Sufficient water tankers shall be deployed to all designated Kanwar camps. A daily schedule for tanker supply, including frequency and volume, must be established and strictly adhered to.
 - Where feasible and safe, temporary water connections or stand posts may be provided to larger, established camp sites, after due technical assessment and approval.
- **Water Quality Monitoring:** Regular testing of water supplied to the camps, both through tankers and temporary connections shall be conducted to ensure it meets potable water standards. Any anomaly must be reported immediately to the Chief Engineer (Operations) and the necessary corrective actions taken.

2. Coordination and Reporting:

- The concerned Superintending Engineer (DJB) will be the coordinators for all coordination efforts with District Magistrates (DMs) related to water supply for the Kanwar Yatra 2025. In case of emergency, not below the rank of Executive Engineer will deal the water supply issues. The list of concerned SEs to coordinate with DMs is as under:
