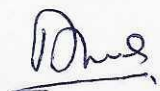

2. The above-mentioned officers may exercise their option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR-22. The actual benefit of promotion will be admissible to the above-mentioned officers only with effect from the date of their joining to the post of Assistant Director (IT)/System Analyst.
3. **Consequent upon their promotion from the post of Data Processing Assistant/Technical Officer (IT) to the post of Assistant Director (IT)/System Analyst, the officer, after being relieved from their present department will submit their joining in IT Department.** Their further posting orders will be issued subsequently as per decision of the Competent Authority. During this period of under posting, they will continue to physically work in their present department as mentioned in the aforesaid list.
4. **The Head of Departments concerned should ensure that above-mentioned officers are clear from vigilance angle before relieving them for joining as Assistant Director (IT)/System Analyst.** If any of the officers above is not clear from vigilance angle or facing criminal proceedings in any Court of Law or has resigned/relieved/expired etc., the same should be brought to the notice of this department immediately.
5. The benefit of promotion will be admissible to the aforementioned officers only with effect from the actual date of joining to the post of Assistant Director (IT)/System Analyst in IT Department.
6. The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Others (Civil Appeal No. 629 of 2022) arising out of SLP(C) No.30621/2011 as conveyed by the DoPT vide OM no. 36012/16/2019-Estt.(RES) dated 12.04.2022.
7. This issues with the approval of the Competent Authority.
