ORDER

In pursuance of Services Department, GNCT of Delhi Services Department order no. 02 endorsed vide No.F.1(25)/2015/NFSG/Gr.III(Steno)/Services/Vol.2/77-84 dated 11/02/2025 regarding grant of Non Functional Selection Grade(NFSG) to Gr.III(Steno) in accordance with the instructions contained in office memorandum no. 20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension(Department of Personnel & Training), the Director(Social Welfare) is pleased to grant Non-Functional Selection Grade to Sh. Amit Bangre, Grade-III(Steno) in the Level-6 of pay matrix table under 7th CPC i.e. Rs. 35,400-1,12,1400/-(Pre-revised Pay Scale of Rs. 9300-34800 in PB-III with Grade Pay of Rs. 4200/-) w.e.f. 01/01/2022.

The grant of NFSG is further subject to the following conditions that:

- (i) The grant of NFSG is subject to the condition that, if there is a change in the date of eligibility in respect of abovementioned officials Gr-III(Steno), in future, due to deletion or addition of names in the eligibility list, he will have no claim over the date of eligibility.
- (ii) The official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the Non-Functional Selection Grade.
- (iii) The grant of Non Functional Selection Grade is subject to the undertaking that in event of over payment, which may be detected at later stage, the same will be recovered from their pay.
- (iv) The official is clear from vigilance angle as per vigilance status report vide letter No. F.3(351)/VC/NG/Vig./DSW/2018/PF/Vol-I/070688873/1093 dated 09/06/2025 issued by the Section Officer(Vigilance), Department of Social Welfare.
