## Roles & Responsibilities :-

1.	SE (M)-Nodal Officer	The authorized officer to issue a work permit for emergency work at the site; SE concerned should be present at site during execution of work and maintain the work permit register for future records at the Nodal office as per the MOHUA advisory.
2.	Executive Engineer	line and further, EE concerned should be proceed
3.	Assistant Engineer	execution of work. To ensure skilled/professional worker entry.  To ensure to implements and follow all safety norms and present at site during execution of work as per PEMSR Act.2013.
4.	Junior Engineer	To maintain all record of permitted skilled/ professional worker concerned of advisory such as:-  Name of worker, Post, ESIC, EPF, Aadhar number, time with total duration of working in the Manhole/confined space etc.
