Sir,

This has reference to email dated 26/03/2021 on the subject cited above. In this regard, it is to inform you that the site was inspected by the officer concerned of this department on 01/04/2021 in the presence of Mrs. Sheetal (Principal) and observed that earlier school was Ground + 02 upper floors but now the school building is comprised of Ground + 02 upper floors and 3rd floor/additional floor also found constructed. Therefore this is a case of additional/alteration and needs to route your application through bldg. deptt. of East MCD. During the inspection following shortcomings were observed :-

1. One additional staircase found removed from Ground to 1st floor.
2. Hose reel found not functional.
3. Fire pump found not functional.

Hence, renewal of Fire Safety Certificate can not be considered at this stage.
