In this connection, it is to inform you that the above mentioned premise was visited by the connection of the subject cited above. premise was visited by the officer concerned of this department on 24.04.2025 in presence of Mr. Himanshu (Manager) and it Himanshu (Manager) and it was observed that building is comprised of Basement + ground + 03 upper floors but restours upper floors but restaurant at ground floor only. During inspection, following shortcomings were observed: observed:

- 1. Exits are blocked by store material & sofa.
- 2. First aid hose reel provided but not functional.
- 3. MOEFA provided but not functional.
- 4. Down comer system provided but not functional.
- 5. Fire pump provided but not functional & not in auto start mode.
- 6. Over head water storage tank capacity of 10,000 liters provided against the requirement of 20,000 ltrs.

In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/ premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
