- Fire extinguishers of ABC/Co2 type not provided against the 05 no's of ABC / Co2 type 2.5 kg capacity required to be provided
- 2. Hose reel provided but not functional & found removed on ground floor.
- 3. Manually operated electric fire alarm not functional.
- 4. Yard hydrants found removed on ground floor.
