In this connection, it is to inform you that the above mentioned premise was visited by the officer concerned of this department on dated 19.06.2024 and observed that the shortcomings intimated vide letter of even No. F6/DFS/MS/NDZ/2023/4174 dated 07.11.2023 (copy enclosed) have not been complied yet.

In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
