Regarding issue of NOC from fire safety point of view in r/o Silverline Public School Sub: -S-623, School Block Shakarpur, Delhi - 92

Sir.

Please refer to letter dated 29.2.12 on the subject cited above. In this connection this is to inform you that officer concerned of this department has visited the School to ensure the fire safety arrangement in accordance with the rule 33 of the Delhi Fire Service Rules, 2010. At the time of inspection Manager of the school was present and observed that the school building is comprised of ground plus three upper floors only. During the course of inspection, the following points / shortcomings were noticed:-

1. Two Co2 type 2.5 kg capacity or two ABC type fire extinguisher with ISI mark were not found provided for every 300 square meters of covered area or part there of each floor

2. Hose reel is not found provided at each floor level.

- 3. Fire pump having 450 liters per minute out put at 40 meters head is not found provided
- 4. Over head water storage tank 10,000 ltrs capacity is not found provided at terrace.

Exit signs are not found provided.

In view of above, the fire safety certificate can not be issued at this stage.
