This has a reference to your mail id kuldeep.lohani@sgrh.com> dated 06.02.2025, on the subject cited above. In this regard, this is to inform you that the site was inspected by officers concerned of this department on 06/03/2025 in the presence of Sh. Kuldeep Lohani (CSO) & Dr. D.S. Badole and following shortcomings were observed: -

Fire check door provided for connection to E block for compartmentation found removed at 4th floor and door closers also found removed from some fire check doors.

Lift lobby pressurization found removed at some lifts.

- Detectors are not provided at some offices required to be extended to left out area.
- Sprinklers at 5th floor of old building is not provided, required to be extended at 5th floor 4.

Basement is being used for office which is not allowed as per sanctioned plan.

- Hose reel and hydrant is not provided at basement required to be extended to basement left
- Corridor and lift lobby found encroached by making it waiting room and storing of other items, required to be removed.

8. Lift signage not provided at some places.

9. Trimming of tree is required to free movement of fire vehicle.

10. At few floors, repairs of AHU and renovation work is being carried out.

In view of above, the case is rejected and fire safety certificate (FSC) cannot be renewed at this stage. Further, the occupancy of building /premises in absence requisite fire & life safety arrangements shall be at the risk and liability of the owner/occupier. The statuary/licensing authority may take suitable action as deemed fit.
