Sir,

This has reference to outdoor diary no. 5776 dated 16.09.2022 on the subject cited above. it is informed that the school building was inspected by Assistant Divisional Officer (M. Road) from this department on 14.11.2022 in the presence of Mr. B.S. Rana (Admin Officer) and it was observed that the building is comprised of ground + 2 upper floors. During the inspection following shortcomings were observed:-

1. An additional staircase is required of width 1.50 mtrs.
2. First aid hose reels found non function.
3. Fire pump found non function.

In view of above shortcomings, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the management. The Authority/Statutory Authority may take suitable necessary action as deemed fit.
