Sub:- Regarding Issuance of Fire Safety Certificate in r/o M/s S.R. Public School at D-62, West Jyoti Nagar, Shahdara, Delhi 110094.

Sir,

This is in reference to your letter No. nil dated 12/02/19 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned school from fire safety point of view in presence of Mrs. Lalita, Principal of the School. During the course of inspection, the following points / shortcomings were noticed in the building comprised of ground plus two upper floors.

 The width of staircase shall be 1.50 meter or an additional staircase of 0.75 meter, shall be provided.

2. First-Aid hose reels (01 nos.) at each floor provided but not functional.;

3. A fire pump having 450 LPM output at 40 meters head not provided.

4. Over Head water storage tank 2,000 liters capacity provided at terrace in place of 10,000 liters as required.

5. Exit Signage were not provided. .

In view of above, the building can not be considered for issue of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
