In view of the above, the application for renewal of fire safety certificate cannot be considered at this stage & rejected. The occupancy of the premises in the absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.

Sub: Regarding renewal of FSC from fire safety point of view in respect of M/s. Star International, at 8172, Arakshan Road, Paharganj, New Delhi.

Sir,

Please refer to your online application no. 2025082112731 dated 21/08/2025, on the subject cited above. In this connection, it is to inform you that the premises was inspected by officer concerned of this department on 04/09/2025 in the presence of Sh. Deepak kumar (Manager) to see the functioning of fire safety equipments provided in the building.

During inspection, it has been observed that the said guest house in a building comprised of ground + 04 upper floors, 4th floor is not in use & owner/occupier has given an undertaking/ affidavit dated 26/09/2019. Ground floor (reception), 1st floor (03 guest rooms) 2nd to 3rd floor (04 guest rooms at each floor), & terrace floor (staff room + staff kitchen sealed by MCD) total (11 guest rooms upto 3rd floor), was issued FSC vide letter no. F6/DFS/MS/GH/2022/421 dated 12/09/2022. Fire safety arrangements such as Fire Extinguishers, MOEFA etc provided. However the following shortcomings were observed.

1. Smoke management system is provided but it is not functional.
2. First Aid hose reel is provided but it is not functional.
3. Automatic fire detection & alarm system is provided but it is not functional.
4. Overhead fire pump of 450 LPM is provided but it is not functional.

In view of above Shortcomings, the application for renewal of Fire safety Certificate is cannot considered at this stage & rejected. The occupancy of the Building/premises in absence of requisites fire safety arrangements shall be at the risk and liabilities of the Owner/occupier.
