## FIRE SAFETY CERTIFICATE (FSC)

Certified that the M/s Suvidha Deluxe Guest House located at 3335 to 3337, Hari Mandir, Pahar Ganj, New Delhi was granted Fire Safety Certificate (FSC) by this department vide letter no. F6/DFS/MS/GH/NDZ/2022/284 dated 14.06.2022 for Ground + 03 upper floor in the building of Ground + 04 upper floors. The Guest House was re-inspected by officer concerned of this department on 21.08.2025 in presence of Mr. Rizwan (Manager) and found that Guest House building is comprised of Ground + 04 upper floors: Ground floor - Reception + 02 guest rooms + Clinic, 1stfloor to 3rd floor - 05 guest rooms each floor, 4th floor- Sealed. The Guest House has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the Guest House is fit for occupancy of Group 'A (Residential) sub division A-1, total 17 Guest Rooms (Ground floor - Reception + 02 guest rooms, 1stfloor to 3rd floor - 05 guest rooms each floor) with effect from One of the fire prevention and valid upto 31.03.2028 in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

## Conditions for the validity of Fire Safety Certificate

- 1. This Fire Safety Certificate is valid for Guest House at Ground + 03 upper floors only.
- The temporary tin shed structure on terrace shall not be used for any commercial activities or occupancy.
- 3. All the fire safety arrangements provided therein shall be maintained in good working condition at all times.
- 4. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
- 5. The trained fire fighting staff should be available round the clock.
- 6. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 7. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 8. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on <a href="www.dfs.delhigovt.nic.in">www.dfs.delhigovt.nic.in</a>.
- The means of escape shall be kept unobstructed/unlocked for unhindered evacuation in case of an emergency.
- 10. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
