With reference to the letter bearing outdoor diary no.5377 dated 27.08.2025 on the subject cited above, it is informed that the site was visited by officer concerned of this department on 13.09.2025 in the presence of Mrs. Shamina Khalil to check the compliance of Fire Safety guidelines issued by this department vide letter no. F6/DFS/MS/BP/2025/273 dated 07.08.2025 and it was observed that the building comprised of Basement + Stilt + Ground + Three Upper Floors. The following shortcomings were observed during the time of inspection:-

- 1. The arrangement of exit staircases is not as per issued guidelines.
- 2. The Smoke Management System is yet to be installed.

In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing Authority/Statutory Authority may take suitable necessary action as deemed fit.
