1.	Width of internal road all around the building is 5.80m instead of required width of 6 meter.	Not Complied
2.	Width of staircase is 1.10m in each block instead of required width of 1.25 meter.	Not Complied
3.	Public address system is provided but not found functional.	Complied
4.	MOEFA is provided but not functional.	Complied
5.	Fire pumps not found on auto-operation.	Complied
6.	Exit signage found removed at some locations.	Complied

In view of above, application for renewal of fire safety certificate is rejected. You are advised to rectify the left-over shortcomings under intimation to this department for further action.
